## ***Terms and Conditions of Membership***

Tustin Hills Racquet & Pickleball Club ("Owner") is privately owned. It is expressly understood that the holders of licenses in the form of memberships shall neither individually nor collectively have any proprietary right or interest in or to any of the properties, assets, facilities, premises, future development and/or other matters or things owned by the Owner.

All memberships to be sold are to be mere licenses which shall permit the holders thereof the right to use and enjoy the facilities for amusement and recreation of an athletic nature which shall be devoted to swimming, tennis, pickleball and health activities.

This membership is non-transferable and may be revoked for failure to follow the Code of Conduct, attached, or failure to pay any amount due. It entitles the member only to a non-exclusive right to use the club facilities

The member agrees to abide by the rules and regulations as they now exist and as they may from time to time be amended or supplemented by the Owner.

The member agrees to pay all amounts due within 10 days of the billing date. Past due accounts will be charged a late fee.

A holder of a membership shall be fully responsible and liable to the club for all obligations incurred or owed to the club by any person entitled to the use of the privileges of the club under such membership.

The Owner shall have the right, without cause, to revoke any membership at any time by giving written notice of revocation to the holder of the membership. If the membership is revoked, the Owner shall pay to the holder of the membership the amount paid, if any, for amounts applied following the revocation date, without any increase.

The member agrees to give the Owner 10 days written notice of cancellation to terminate their membership. Any notice of cancellation less than 10 days and the member will be charged another month's dues.

The monthly dues may be increased at the discretion of the Owner at any time without written notice.

The Owner reserves the right to close the club for two weeks in any one calendar year without adjustment to membership dues so as to extend vacation privileges to its employees and/or to make repairs or improvements to the facility. The Owner reserves the right to permanently close the club for any reason at which time membership obligations will cease.

Except as otherwise herein provided, the club is not obligated to repurchase a membership for any reason whatsoever.

The privilege of membership will carry no right of participation in the management or control of the club, or of any of its facilities.

The member assumes all the responsibilities and risks associated with the use of the club and its facilities, including, without limitation, use by their family members and their guests. The member and their family members agree to indemnify and hold the club, its agents, and employees harmless from and against any and all damages, liability, and costs (including reasonable attorneys' fees) arising from the use of the facilities by holder of this membership and his or her family and guests.

**Disclaimer:** The Club is not responsible for any injury to, including death, or loss of property, of any person suffered while on the Premises or participating in the use of the Premises for any reason including but not limited to playing tennis, pickleball, swimming, using the gym facility, or spectating or any other activity occurring in or about the Premises.

In consideration of my participating activities and use of the Premises, I hereby release from, and covenant not to sue members, directors, officers, employees, representatives, agents, lessors and lessees for, any and all present and future claims resulting from negligence, inherent risk of sport or exercise or otherwise; including but not limited to any loss, injury, damage or liability sustained by me while on or about the Premises.

I am fully aware and understand that the Club does not employ or contract with any medical service providers for ordinary or emergency medical services, including but not limited to emergency cardiovascular assistance. I will be fully responsible for any use I make of medical supplies or equipment which may be found on the Premises and agree that the terms of this waiver and release shall apply to any person who in good faith uses such supplies or equipment to assist me if I am unable to do so.

I am also fully aware and understand that losses, injury, damage, liability, disability, or even death may result from actions, inactions or negligence on my part, on the part of the Club, or on the part of others, as well as from the rules of play of tennis or pickleball and the condition of the Premises.

I further agree that I am knowledgeable in the proper use of the Premises and with the risks inherent in playing tennis or pickleball. I also understand that the pool is not supervised and there is no lifeguard on duty. If a minor(s) accompanies me, I take full responsibility for the use of the pool and its premises by the minor(s).

I assume all the foregoing risks and accept personal responsibility for any damages and loss following any loss of property, injury, permanent disability, or death resulting from my use of the Premises or participation in any Club activities.

I have read and fully understand the above waiver, release, and assumption of risk and fully understand that I have given up substantial rights by signing this waiver, release, and assumption of risk, and sign it voluntarily.

## CODE OF CONDUCT AND GUEST POLICY

This Code of Conduct is designed to ensure a positive, respectful, and enjoyable environment for all members of the Tustin Hills Racquet & Pickleball Club. We expect all members to adhere to these guidelines.

### Good Sportsmanship

**Respect:** Treat all players, officials, and spectators with respect. Avoid arguments and maintain a positive attitude.

**Fair Play:** Play fairly and honestly. Do not cheat or take advantage of others.

**Encouragement:** Encourage your fellow players. Applaud good plays, regardless of which player or team made them.

### Court Etiquette

**Walking Through Courts:** To minimize disruption, only walk through courts after a point has ended. Wait for a suitable break in play before crossing behind a court.

**Cleanliness:** Keep the courts clean. Dispose of trash properly and leave the court in the same condition you found it.

**Appropriate Language:** Use respectful and appropriate language at all times. Profanity is not permitted. While we want you to have fun, please keep the yelling and shouting to a minimum, as it can be perceived as a hindrance to play on other courts.

**Appropriate Attire:** Wear appropriate tennis or pickleball attire when on the court. This includes tennis shoes, shorts or skirts, and a comfortable shirt. Please note that shirtless play is not permitted.

### Guest Policy

We welcome members to bring guests to enjoy our facilities. To maintain the quality of our services and ensure the safety and satisfaction of all members, we have established the following guest policy, which includes a fee of **\$35 per guest**.

Note: Unregistered guests will be charged directly to the member who booked the court.

**Advance Notice:** Members are encouraged to inform the front desk in advance when planning to bring a guest. Walk-in guests are permitted but must be registered upon arrival.

**Member Responsibility:** Members are responsible for their guests at all times during their visit. Guests must adhere to the same rules and regulations as members.

**Guest Fee & Payment:** A guest fee of \$35 will be charged per guest, per visit.

If not paid at the time of registration, prior to play, this fee will be billed directly to the member's account. Members are responsible for settling guest fees promptly.

**Check-In Requirement:** Guests must check in at the front desk upon arrival. Failure to check in may result in the guest fee being billed directly to the member who booked the court or facility.

**Court Reservations:** For court or facility reservations, the member making the reservation is responsible for ensuring that their guests check in at the front desk. Guests without proper check-in will have the guest fee billed directly to the member who booked the court.
